# BUDGET CONSIDERATIONS 2018-2020

Balancing the 2018-2020 budget was a topic of discussion at the CA executive board meeting held November 5, 2017. The CA state budget is based solely on income from the member's state dues As our membership declines, the state income declines. However, costs continue to increase. The board discussed several possibilities, but is primarily considering two at this time: combine the Recording and Corresponding Secretary positions to eliminate one position on the board; and/or 2) increase dues by \$5.00. The board will make a decision at its January meeting and would appreciate your input. You will receive a survey via email. All input will be read and considered by the board.

# CHAPTER SALES ALLOWED AT STATE CONVENTION

Chapter altruistic sales may take place at the state convention in Santa Ana. The application must be accompanied by a \$20 donation to benefit the State Altruistic Project. The application deadline is **April 1, 2018**. Space is limited.

## LEONARD GRANTS FOR MEETING ATTENDANCE

Noel Leonard, CA state president 1992-1994, left a legacy to CA Alpha Delta Kappa making it possible to award \$100 grants to first time attendees at the CA state convention. One grant is available to each council. Each chapter may nominate one member who has not attended a CA state convention and who shows promise of leadership in the organization. The council president shall conduct a random drawing to determine the recipient of the Noel Leonard Grant for first-time attendees to the CA state convention. The council presidents will notify the state president of their selections by April 1, 2018. In a second part of her legacy, Noel left funds for \$100 grants to council officers or a council designee to attend regional conference to further their leadership skills. One grant is available to each council. The council president must notify the state president no later than June 1, 2018.

#### PEARL VISION

"Each one reach one" is the approach suggested by state president, Diana Galvan, to meet the new 7-Pearl requirement to initiate or reinstate at least one new member this year. The new requirement replaces the former "positive net growth" requirement which was challenging for some chapters to achieve.

Initiation of new members should take place between June 1, 2017 and March 15, 2018 for chapters to be considered for the CA Perpetual Membership Award to be presented at the state convention in May.

The International member campaign takes place between January 1, 2018 and April 30, 2018.

#### **EXECUTIVE BOARD ACTIONS**

At the Executive Board Meeting held October 6 and 7, 2017 in Fairfield, the following actions were approved:

- Funds from the \$1,065.00 donated by chapters for unexpected I.T.E. expenses will be disbursed as follows: \$150.00 to Sara Armstrong, Alpha Alpha, for flight costs for the I.T.E. Weekend, and \$915.00 to I.T.E. student Eli Ugarte.
- The Fresno Council was renamed Fresno/Modesto Council to reflect the change in membership.

At the Executive Board Meeting held November 4 and 5, 2017 in Fresno, the following actions were approved:

- Send a \$250 donation from the account for altruistic projects to the International Foundation designated to be used for hurricane relief.
- Purchase a smaller, possibly bulbless projector, from the account for equipment, not to exceed \$500.
- Approve new or revised Policies and Procedures in the following areas, with an action date of November 5, 2017:
  - o Section E, State Altruistic Projects,
  - Section E, International Altruistic Projects,
  - o Section F, Districts/Councils,
  - o Section G, State Convention.
