A monumental decision by the International Executive Board will allow retired teachers who "continue to demonstrate a genuine interest and active involvement in the current educational process" to be invited to become members of Alpha Delta Kappa.

International President, **Ruth Ann Griggs**, states, "Our mission remains the same, Alpha Delta Kappa builds educational excellence, altruism and world understanding through fellowship. Alpha Delta Kappa remains an organization for women educators; now some new members will be in the classroom and some will have retired. Our membership still needs to grow and we need to initiate both active educators and retired educators who are still interested in and connected to education."

A new membership application (H-103) identified by **R-17** at the top of the form will soon be available on the international website.

Retired teachers may be initiated into active chapters after January 1, 2017. Fidelis chapters may not initiate new retirees at this time.

I.T.E. WEEKEND

Kansas City, International Headquarters, November 11-12, 2016. What is I.T.E.? International Teacher Education. I.T.E. student Elisa Ugarte from Chile, along with her cosponsors, Sara Armstrong and Joanne Grimm from Alpha Alpha chapter in Oakland traveled to Kansas City to attend the meeting of all Alpha Delta Kappa I.T.E. students and their sponsors along with the International Board. The purpose of the event was to share their experiences in the field of American education.

I.T.E. students receive \$10,000 to further their studies toward a career in teaching.

Begun in 1961 as an international altruistic project, to date Alpha Delta Kappa has sponsored over 200 students from more than 40 countries.

Following three years of teaching English and history in junior high in the Fresno Unified School District, I received an invitation to attend a meeting concerning ADK, an educational sorority for women. Shortly afterward, I joined the new Gamma Chapter [in 1953] and I am still a member 63 years later. I still enjoy the members, programs, and especially the altruistic projects. During the years, I was twice president of Gamma Chapter and involved many times in choosing and assigning scholarships.

I taught for five years and was dean of girls and vice-principal for 26 years. [Women weren't allowed to be school principals then.] I still think that working in education is one of the most important jobs that one can have, especially today.

Now I live in a senior center and am a member of our Senior Dog Squad, cheerleading at Fresno State football and basketball games occasionally.

Beverly retired from her life-long career in the Fresno Unified School District in 1988.

Past California State President, Mollie Acosta from Fresno's Xi chapter, is a candidate for International Vice President of the Southwest Region. The election will take place at Alpha Delta Kappa's International Convention in New Orleans next summer.

Each chapter in the Southwest Region is entitled to two voting delegates who will elect the next SWR IVP as well as determine other bylaws changes at the convention.

Convention dates are July 12-15, 2017. Location is the Hilton Riverside Hotel in New Orleans, Louisiana. Registration and hotel reservations begin January 4, 2017. Chapters are encouraged to support the attendance of their two chapter delegates.

Jessie Rees was a beautiful, athletic, smart and compassionate 12 year old girl who bravely fought two brain tumors (DIPG) for ten months and two days. Her fight started on March 3, 2011 and ended on January 5, 2012 when she earned her angel wings. During her courageous fight, Jessie decided to focus on helping other kids fighting cancer that couldn't leave the hospital. This desire led to the creation of her fun-filled JoyJars and Never Ever Give Up (aka: NEGU) message. Today, JoyJars and NEGU are recognized symbols of hope, joy and love in over 29 countries.

SUMMARY OF EXECUTIVE BOARD ACTIONS

<u>August</u> -Approved the expenditure of \$456 for partial refunds of State Convention registration to sisters who requested refunds because they were unable to attend due to extenuating circumstances.

-Approved acceptance of policy covering chapter sales at district conferences.

<u>October</u> -Approved the use of unexpended State Convention funds, allocating those funds equally among scholarship, altruistic and leadership projects.

- -Approved revisions to Policies and Procedures for the areas of hospitality suites at regional conferences and International Convention
- -Approved change in name for two councils, changing Fresno/Clovis to Fresno, and Bakersfield/Delano to Bakersfield.

<u>November</u> -Approved the Policy and Procedure regarding the State crisis fund.

-Approved a donation through the Alpha Delta Kappa Foundation of \$175 each to North Carolina and Louisiana for hurricane disaster support.
