## First Business Session - Delegate Seating

## Opening

Presiding officer, California State President Mary Ann Englehart, welcomed everyone to the 31st California Alpha Delta Kappa State Convention, and the Visalia Wyndham Hotel. She called the meeting to order at 9:03 A.M., and directed the sergeant-at-arms to close the doors.

## Parade of Presidents/Roll Call

California State Sergeant-at-Arms Sara Cooper announced the councils and chapters in attendance. Each council or chapter president or designee entered the Convention, with most carrying their banners. The president of Xi, President Mary Ann's chapter, entered first, followed by the president of Gamma. These two chapters comprise the host council, Fresno/Clovis. President Mary Ann announced that 36 chapters were represented, almost three-fourths of the State's chapters.

## Presentation of Colors/Pledge of Allegiance/National Anthem

President Mary Ann introduced the Reedley High School N.J.R.O.T.C., with instructor Christopher Bodine. State Sergeant-at-Arms Sara Cooper led the Pledge of Allegiance, followed by singing of the National Anthem, led by Xi sisters Christel Biasell and Mary Frances Gomez. President Mary Ann thanked the color guard, instructor, Sara Cooper, and Xi sisters, Christel and Mary Frances.

## **Opening Thought**

State Chaplain Joanne Grimm shared the Opening Thought. Joanne began by reflecting upon her responsibility as a chaplain to set the tone of a meeting. She said that a convention is different from other meetings. In analyzing the purposes of attendance at conventions, she found that the advantage of that attendance is interacting with others. Joanne asked members to think about their reasons for attending convention. She declared the tone to be "interactive friendship." She charged sisters to "take care of business, but while it's getting done, let's interact like crazy."

## Presentation of Executive Board and Honored Guests

President Mary Ann introduced the 2014-2016 California State Executive Board, and stated that it had been an honor and profound pleasure to work with them, as "sisters of the heart."

On behalf of Gamma and Xi chapters, Fresno/Clovis Council, she welcomed sisters with the hope that the Convention would provide opportunities for participation in business and for celebration of California sisters with heart. She introduced the convention committee chairmen for recognition.

Mary Ann thanked the hotel for being wonderful to work with. She also thanked Catering Sales Executive Erin van den Broecke for her efforts.

## Greetings from International Representative Ann Marie Brown, International Vice President, Southwest Region See Appendix

President Mary Ann shared background, achievements, and interests of International Vice President Ann Marie Brown, who then expressed greetings from International Alpha Delta Kappa. She reminded members of the International theme, "Inspire, Embrace, Achieve." She congratulated President Mary Ann and her leadership team. She introduced sisters who are serving at the International level: International Resolutions Committee member Susan Raffo, International Innovations Grant Committee Chairman Mollie Acosta and her committee members Mary Ann Englehart, Lynne Keating and Virginia Riding. She also thanked Susan Raffo and Mollie Acosta for service at regional level.

She invited members to attend Northwest/Southwest Regional Conference August 1-3, 2016, in Albuquerque, New Mexico, and International Convention in New Orleans, July 12-15, 2017. She thanked California sisters for greetings and hospitality, and closed by inviting sisters to introduce themselves to her, and to share ideas.

President Mary Ann thanked Ann Marie for her gifts to the State Executive Board.

Sandi Roullier, Beta Eta, was added from the floor as a Silver Sister. President Mary Ann thanked the Golden, Sapphire and Silver Sisters for attending. She then asked first-time attendees to stand, and announced that eighteen were present. Leanne Miura and Gamma sisters presented them with tokens to commemorate their presence. Mary Ann asked sisters to welcome and thank the first-timers who would be wearing purple bows.

The Noel Leonard Grant for first-time attendees at State Convention was explained by President Mary Ann. Councils receive one \$100 grant for every four chapters in the council. Mary Ann announced recipients and asked them to come forward to receive their checks from State Treasurer Karen Kirby.

**Introduction of Convention Parliamentarian Dollie McPartlin, Nevada Past State President** President Mary Ann thanked Convention Parliamentarian Dollie McPartlin for joining California sisters once again, and for bringing her expertise to Convention.

## Registration and Credentials Report (moved to this point in Program, at direction of **Convention Parliamentarian**)

Convention Registration Chairman Linda Barker presented the first Registration and Credentials Report.

MOTION: "On behalf of the Credentials Committee, I move that the roll of delegates from the credentials committee be the official roll of the Convention." There were no questions, and the motion passed. President Mary Ann declared the delegates seated.

## **Adoption of Rules of Convention**

Convention Chairman Mollie explained that since the Rules of Convention were included in the registration packet, she would not read them aloud. She called attention to the process for making and speaking to motions, printed on the reverse side of the Rules of Convention.

**MOTION:** "On behalf of the Rules Committee, I move the adoption of the Rules of Convention for the 2016 California Alpha Delta Kappa State Convention." There were no questions, the motion passed, and the Rules of Convention were adopted.

## **Acceptance of Convention Program**

Convention Chairman Mollie explained that Madeline Schultz spoke for the Wyndham instead of Erin Van den Broecke as printed, as Erin was unable to attend. She then stated several items that were moved to different places in the program order.

- Introduction of Parliamentarian Dollie McPartlin was moved to follow Introductions and Honors.
- The Credentials Report was moved to follow Introduction of Parliamentarian.
- Following the speaker for "The Longest Day," Strategic Conversation Conducted by Ann Marie Brown was inserted.

A name correction for Entertainment was stated, to change "Board" to "Ford," however a sister explained that "Board" is correct. Kathleen O'Malley was substituted for Barbara Murray for providing the Excellence in Education report, since Barbara was ill and unable to attend. Kim Gerould was listed twice as a speaker, but will speak only before lunch.

**MOTION:** "On behalf of the Convention Committee, I move the adoption of the Convention Program as corrected." There were no questions, and **the motion passed.** The 2016 Convention Program was adopted as corrected.

President Mary Ann declared the 31st California Alpha Delta State Convention officially in session.

President Mary Ann called a stretch break for three minutes, while the sound system was fixed. After the break, Mary Ann announced a Noel Leonard grant recipient, whose name had been missed, Connie Baker from Sierra Council. She was presented with a check. Vivian Hillig-Hawley was also recognized as a Silver Sister.

## 2014 Convention Minutes Approval Committee Report

President Mary Ann announced that the 2014 California State Convention Minutes were read and approved by committee. The committee members who will read and approve the minutes for the 31st California State Convention will be Susan Raffo, Beta Rho; Carol Valcarcel, Gamma Nu; and Anne Hertwig, Xi. She explained that the official minutes of this Convention will be published by the first district conference of the new biennium. They will be posted on the website, and printed copies will be sent to those who requested them on their registration forms.

## Correspondence

State Corresponding Secretary Kathleen O'Malley was recognized for stepping into her position after Kerry Hackman needed to resign due to a new job. Correspondence was shared.

- A thank-you note for gift of funds from "Teachers Helping Teachers" was received from Valley Fire victims, the Bertram family, of Cobb, California.
- Barbara Stanfield. Chairman, International Executive Board, sent congratulations to President Mary Ann and the sisters of California who provided leadership during the biennium. She also sent best wishes to Diana Galvan and the new team who will lead California during 2016-2018.
- Ruth Ann Griggs, International President, 2015-2017 Alpha Delta Kappa, sent a letter of greeting to Mary Ann and California Alpha Delta Kappa sisters, wishing success at Convention. She also thanked Mollie Acosta and her team for leadership, as well as thanking those who will lead California during 2016-2018

## Treasurer's Report: Presentation of the 2014-2016 Budget and proposed 2016-2018 Budget See Appendices

President Mary Ann explained that State Treasurer Karen Kirby would present the Treasurer's Report and the Proposed 2016-2018 California State Budget, and that copies were posted online, and included in the registration packets, along with Budget Descriptions.

State Treasurer Karen invited chapter treasurers to stand, and thanked them for having all C-1 reports and e-postcards turned in. She introduced members of the Budget Committee: Pam Mallory, Beta Pi, Northern District; Hilary White, Gamma Tau, Marina District; Karen Evans, Lambda, Valley District; and Ann Rendon, Iota, Southern District.

Treasurer Karen presented her report, with account balances as of April 28, 2016.

Treasurer Karen pointed out that in the current budget, dues received totaled less than budgeted, due to fewer dues-paying members. Karen also mentioned that Noel Leonard funds will be available for use by councils to send a leader to the Northwest/Southwest Regional Conference.

**MOTION:** "As Chairman of the Budget Committee, I move the adoption of the 2016-2018 California State Budget." President Mary Ann asked if there were any questions. There were none, and **the motion passed** unanimously. President Mary Ann declared the 2016-2018 California State Budget adopted.

President Mary Ann thanked Karen and her committee.

#### **Bylaws**

President Mary Ann invited Bylaws Chairman Susan Raffo, Beta Rho, to come to the podium. Susan Raffo thanked all chapters for stepping up to submit their bylaws, and reported that 100% of chapters submitted bylaws and were certified. She referred sisters to information about the history of bylaws since 2013 International Convention. She stated that amendments to International bylaws had been received via email and were included in the registration packets.

"Delegates to previous California state conventions voted on amendments that align California State Bylaws with International Alpha Delta Kappa Bylaws. Those amendments to our state bylaws are necessary to maintain alignment with the International Bylaws and to meet IRS requirements for non-profit status.

"In preparation for the 2016 California State Convention, all California chapters received notification of amendments to the International Bylaws approved at the 2015 International Convention. The International Bylaws document was approved as the governance document for the state of California and individual chapters.

"As stipulated in the International Bylaws, the delegates to the state convention will acknowledge the receipt of the amendments approved at the 2015 International Convention by approving the alignment of the California State Bylaws to be in compliance with the language of

the International Bylaws and with the current Bylaws of the Alpha Delta Kappa Sorority, Incorporated."

**MOTION:** "Therefore, as Chairman of the Bylaws Committee, I move that the California State Bylaws shall be aligned with the International Bylaws as amended at the 2015 International Convention, including the incorporation of editorial changes suggested by the International Bylaws Committee." President Mary Ann restated the motion, and explained that a simple majority was needed for passage. She called for the vote, and **the motion passed**.

Chairman Susan explained that she will align the state bylaws at the close of convention, They will then be posted on the state website, and in Fall 2016, the state bylaws chairman will contact chapters about aligning their bylaws in preparation for re-certification for 2016-2018. She thanked chapter bylaws chairmen and all of the chapters for re-certifying their documents, and added a recommendation that all certification letters be in digital format the next biennium.

President Mary Ann thanked Susan for her hard work, and for clarifying the process.

## Resolutions

President Mary Ann welcomed Resolutions Chairman Michelle White, Alpha Pi, to the podium. Chairman Michelle explained the resolutions.

"There have been two resolutions submitted to the Resolutions Committee. The two resolutions will be presented and voted on separately. The California State Executive Board submitted the first one in November of 2015. A copy of this resolution was included in the registration packet and was sent to all chapters. Please take it out for reference. The resolution reads as follows:" (See Appendix for full text.)

"Resolved, That the California Executive Board amend its Policies and Procedures to allow California chapters to conduct sales of items at District Conferences, with proceeds dedicated to designated altruistic projects and/or scholarship funds."

President Mary Ann stated, "Adoption of this resolution would charge the State Executive Board to review and take appropriate action to implement the resolution adopted today." She then asked for discussion or amendments to the resolution.

- Carolyn Rising, Alpha Nu, Peralta Council, spoke in favor of the resolution. She stated her chapter's belief in their altruistic projects, \$1500 per year scholarship, recognition of exceptional teachers, and donations to disaster victims. She explained that chapter card sales have raised \$2,195 for George Mark House. She stated that the chapter would appreciate opportunities for sales.
- Mari Page, Gamma Mu, asked a question about how a decision would be made as to which chapters would be allowed to sell. President Mary Ann explained that if the resolution passed, the Executive Board would set up procedures.

- Susan Raffo, Beta Rho, clarified that passing of the resolution does not change the bylaws, that the Executive Board would take action to review the bylaws and potentially set up procedures for implementation.
- President Mary Ann checked with the parliamentarian to see if it was appropriate to give some background. Parliamentarian Dollie McPartlin replied that a brief explanation was allowed. President Mary Ann explained that currently chapter sales are not allowed at district conferences, that the Board considered input from chapters that requested to sell, and then put forth the resolution, in order to get approval or denial from members.
- Linda Barker, Gamma, spoke to clarify that the resolution referred to district conferences only, and not state conventions.
- Karen Evans, Lambda, asked whether sales had ever been allowed at district conferences. The reply was "No," because usually there was a council project for altruism or to defray expenses, and chapter sales might impact fundraising for the other purposes.
- Janet Armstrong, Gamma Kappa, asked a question about when the sales might take place, before or during the conference. President Mary Ann explained that the board would examine factors and set guidelines if the resolution passed.
- Sara Cooper, Beta Iota, stated that space and cost of tables would possibly need to be examined, and at state conventions if all chapters wanted to sell, there would be a need for 53 tables.

Discussion and questions ended, and President Mary Ann stated, "The question is to accept the Resolution presented by the State Executive Board. A majority vote is required." She called for members to stand to vote. **The motion passed**, with three delegates opposing.

Chairman Michelle White introduced the second resolution, which was also submitted by the California Alpha Delta Kappa State Board. (See Appendix for full text.)

"Resolved, That the California Executive Board explore establishing a permanent fund to support teachers who have suffered losses through natural disasters to be funded by volunteer contributions of California Alpha Delta Kappa." She then explained that the last sentence was left off the copy that was mailed, "Monies from this fund would be given directly to those who experienced loss."

- Lora Ginsberg, Alpha Psi, spoke in support of the resolution. She mentioned the funds that teachers expend to provide classroom environments, and the loss that happens when a classroom is destroyed. She stated that helping to alleviate pain, suffering and loss is what sisters do. She also pledged to donate to such a fund in honor of Mayme Chinn and Dorothy Vaio, and encouraged a "Yes" vote.
- Kathleen O'Malley, Gamma Eta, asked a question regarding substitution of the word "educators" for "teachers," which had earlier been done. President Mary Ann clarified that the word "teachers" should be changed to "educators" throughout the resolution.
- President Mary Ann stated that the wording of the last sentence was included to ensure that funds would go directly to the teacher, not the district.

- Rosemary Heenan, Alpha Pi, spoke in favor of the resolution, sharing how fire, flood and the San Bernardino shootings had impacted her area, and how much it meant to know that people cared.
- Andrea Street, Gamma Zeta, asked for clarification as to who would administer the fund. President Mary Ann indicated that the State Board would set up guidelines and process, with direction from membership.
- Kim Gerould, Beta Eta, asked if setting up such a fund would limit how the funds were used. President Mary Ann indicated that this would be addressed by the State Board.
- Lynne Keating, Gamma Eta, stated that since there may be some instances of crisis that are not natural disaster, we might want to broaden the scope of the fund. President Mary Ann asked if Lynne was suggesting an amendment, and Lynne said, "Yes."

President Mary Ann read the amended resolution, "That the California Executive Board explore establishing a permanent fund to support educators who have suffered losses through natural disasters or crisis, to be funded by volunteer contributions of California Alpha Delta Kappa sisters." She asked for a second to the amendment. Mari Page, Gamma Mu, seconded. President Mary Ann asked for discussion. There was no discussion, and President Mary Ann instructed members to vote on the amendment only. **The amendment passed**.

President Mary Ann asked delegates to vote on the motion to approve the resolution as amended. **The motion passed**, with three delegates opposed, and was adopted as amended.

June Carroll, Alpha Nu, asked a question regarding timeline for implementation, and President Mary Ann replied that the State Executive Board meets four times per year.

## Nominations for State Altruistic Project for 2016-2018

State Altruistic Project Chairman Linda Barker, Gamma, recognized members of her committee: Kim Gerould, Beta Eta, Northern District; Maureen Chase, Xi, Valley District; Carol Valcarcel, Gamma Nu, Marina District; and Gretchen Nakanishi, Psi, Southern District

Chairman Linda expressed that it was an honor to have a role in nominating worthy projects for consideration. She explained that since the list of nominees was sent in the pre-convention packet to chapters and councils, that she would not read the full descriptions. The projects nominated were: "Break the Barriers - Secret Pocket Scholarship Fund," "Nothing but Nets," and "KidSingers." Linda said that concerns had been expressed, which would be discussed post-convention. She thanked the chapters that nominated projects.

President Mary Ann thanked Linda and her committee, and reminded delegates that the projects would be on the ballot.

## Presentation of Candidates for State Executive Board

Pam Burris, Gamma Nu, for Susan Blough, Zeta, chairman of the Candidate Qualification Committee, thanked members of the committee: Sara Armstrong, Alpha Alpha, Northern District; Kathy Layman, Chi, Valley District; and Pam Horton, Gamma Eta, Southern District.

President Mary Ann asked Pam Burris if there were any nominations from the floor. Pam stated that the nominations committee reviewed applications from two candidates and found them to be qualified. They were included on the poster displayed in the foyer. President Mary Ann asked sisters who would nominate the candidates to step to the microphone. The nominations were:

For Treasurer, Marlene Cordova, Phi, nominated by Susan Raffo, Beta Rho, Past State President

For Historian/Sergeant-at-Arms, Mary Krause, Beta Tau, nominated by Connie Adams, Beta Tau president

President Mary Ann stated, "Hearing no other nominations, the Chair declares there is no further intent to nominate and nominations are closed. Chairman Pam will now make the formal presentation of candidates for state office. As your name is read, each candidate for office, please step forward." Pam Burris read the names. President Mary Ann thanked her for stepping in for Susan, and said that explanation of the balloting process would follow Announcements.

## Video of ITE Student, Eli Ugarte, from Chile

President Mary Ann invited Joanne Grimm, Alpha Alpha, one of the sponsors of California's ITE student, to tell sisters about Eli Ugarte. Joanne explained that Sara Armstrong from her chapter is the primary sponsor for Eli. Joanne shared stories and information about Eli, about Eli's self-sufficiency, her teaching career in Chile, her visits from her family, her interest in university life at Berkeley, including sports, and what a pleasure it is to host her. Joanne shared a video that featured Eli speaking about her university project and research into the relationship between children's success in school and parental involvement. Eli also spoke about social/ emotional learning interventions, program implementation stress, and student resiliency. Eli will complete some fieldwork in Chile, and hopes to return to Chile, where she feels her work is much needed. Joanne shared Eli's thanks for support, and explained that Eli did not attend, because as a Fulbright scholar she is spending a weekend in Washington, D.C.

## Speaker: Kim Gerould, Beta Eta, CA Excellence in Education Recipient

Susan Goto, Beta Eta, Past State President and Past International Vice President for the Southwest Region, introduced Kim Gerould. She shared Kim's background, educational and career history and her current assignment, as an elementary teacher, who developed and implemented a K-2 multiage program at Green Hills. She is the California recipient of the Excellence in Education 2014 award.

Kim Gerould explained the format of her multiage classroom, the benefits, environment, and learning. She spoke of the natural mentorships that develop, and shared service projects that promote caring in students. She reminded sisters, "Children don't care how much you know, until they know how much you care," emphasizing the importance of building connections and relationships. She suggested that sisters create a wordweb of three words that represent the heart of what they do and why, and to keep the web close, and add to it. She also showed a PowerPoint of her multiage classroom.

President Mary Ann thanked Kim and said it was an honor to have her as a sister.

#### Speakers: A Thank You to St. Jude

Catherine and Audra Koelewyn spoke of their experiences with St. Jude since Audra's diagnosis of a brain tumor thirteen years earlier at age three. Mrs. Koelewyn shared the journey from diagnosis to local treatments, to St. Jude, and the comprehensive treatment and care that followed. She spoke of the treatment of the whole child and support for families, shared that Audra's tumor is shrinking, and thanked Alpha Delta Kappa members for supporting St. Jude.

#### Speaker: "The Longest Day"

Rachel Doherty, Alzheimer's Association, provided information about "The Longest Day" awareness and fundraising project, with the goal of having teams compete for sixteen hours on the summer solstice sunrise to sunset, the "longest day" of the year, or on another day. Support and ideas may be found on the organization website, and a flier was provided in packets.

She explained the beginnings of School on Wheels, to its status today with a staff of 30 who train and oversee volunteers who have worked with more than 3,500 homeless students in Southern California.
