California Alpha Delta Kappa 2016 State Convention Convention Chairman's Report

Planning of this convention began late in 2014, with State President Mary Ann and myself considering and contacting potential sites. It became evident fairly quickly that the Visalia Holiday Inn (at the time) would be the most economical, particularly with regard to meal costs; it was our priority to keep registration costs as low as possible. We finalized the contract with the hotel about one year out from the convention. Our contact person was very easy to with, and fortunately she was the only person we dealt with for both the contract and the convention planning itself (often two separate offices within a hotel). The negotiation of the contract itself is critical; it is vital that details are included to cover every aspect (for example, the location for the incoming president's reception folloing the banquet should be included in the total facilities booked). The hotel changed management and switched to Wyndham Visalia in October of 2015; however our contract was completely honored and our contact person thankfully remained the same. Most details with the hotel were worked out via e-mail; President Mary and I made three or four visits prior to the convention. Once the venue had been selected, postcards were prepared with the convention dates and hotel contact information and distributed at all District Conferences the 2nd year of the biennium.

Planning with the full Convention Committee began in late 2015; meetings were held with our host council, the Convention Treasurer, Registration Chairman and Decorations Chairman. I created the Registration form and Google Registration Form and we compiled all documents to be distributed out in late January, 2016. All documents were posted on the State website with State Newsletters and e-blasts informing members. Our Music Chairman came aboard in early 2016. There was extensive communication with State Board members regarding their needs for particular events (for example, setup for the Omega service). Once again, our contact at the hotel was very flexible and allowed small changes in setup (on Banquet Event Orders) up to a week before the convention.

As Convention Chairman I created the convention program in concert with President Mary Ann. It was sent to the Convention Parliamentarian for review and approval (as to the order of business) about four weeks in advance of the convention. President Mary Ann and President-elect Diana created the banquet program and State Chaplain Joanne created the Omega Service program. This division of labor helped lighten the load on the Convention Chairman and was greatly appreciated.

Help was solicited from other Valley District chapters since our local council has only two chapters; still, a few sisters did a LOT of work. I am eternally grateful to President Mary Ann, Registration Chairman Linda Barker and fellow Gamma sister, Leanne Miura, Treasurer Barbara Stein, Decorations Chairman Trina Schneider, and Music Chairman Christel Biasell. All of these sisters worked tirelessly to help the convention be a success.

Evaluations were included in the registration materials; 69 responses were compiled. Of these, 93% of the responses were positive (answering 'Yes' to questions such as 'Were you satisfied with the registration process?' and 'Were presentations and entertainment well done?'). There were comments mentioning the low attendance; there were 110 paid attendees. This is significantly lower than average attendance has been - about 73% of what our state convention usually has in attendance. We will send out a survey of chapter leaders to obtain feedback as to

the reason for this. Thank you notes were sent to the International representative, speakers, hotel personnel, and sisters who performed the many necessary tasks which contributed to the success of the convention.

Recommendations:

- 1. Consider hard copies of convention registration materials being sent at least to Council Presidents. I feel it is important that chapter leaders have an opportunity to **see** all of the materials in order to assure complete distribution of them and discussion so that delegates are prepared for voting.
- 2. For the Friday night 'Meet and Greet' perhaps publish that hors d'oevres will be served only for the first hour or so (evaluations reflected a disappointment when they were gone after about an hour).
- 3. Consider Co-Convention Chairmen with one being local to the selected site.
- 4. Encourage as many chapters and sisters as possible to be actively involved; this shares the myriad of tasks and encourages attendance.

Mollie and Ted ran the name labels for the name badge and the registration envelope. The week before the convention my Gamma friend, Leanne Miura and I prepared the 125 packets to be handed out at the convention. I felt the packets looked very professional which included names on the front of the large envelope, name tags and food selection tickets in separate huge success thanks to the planning of Mollie and Mary Ann. Free parking was a real plus since conventions in the Bay Area and Southern California are more costly. The Wyndham couldn't have been a better choice. They were so helpful with every detail I could see.
