1. Call to Order

4. Opening Thought

10.2. State Membership Committee

The CA Executive Board are all members of the State Membership Committee. The board are liaisons to the Councils so the board must bring up Membership at every meeting. There's a monthly analysis for the region.

10.3. Golden Sister Congratulations

Karen asked Mari to share the congratulations e-cards she sends to new Golden, Silver, Sapphire Sisters.

The meeting was recessed at 6:00 P.M.

The meeting was reconvened at 3:15 P.M.

11. Reconvening Thought

Virginia shared an anonymous poem that does not have a title. Six people claimed to be the author. The theme is that smiling is infectious. The moral is: Cover your mouth when you cough, but never when you smile.

12. Historian Report/Snapfish Book Progress

Rosena warned the board that the historians should only use SAVE and not SAVE AS because if SAVE AS is used it can delete everything that Rosena has done. Rosena has two chapters that have almost completed their two pages for the President's book. These two chapters just have to add captions and chapter names. Rosena will let all the state historians know about using only SAVE and not SAVE AS. Karen suggested that Rosena send this information as a screen shot. Karen has found this technique to be helpful.

13. Unfinished Business

13.1. Excellence in Education

The Excellence in Education Award form is no longer on the California website. The revised form came out in July. The whole process has changed. A link to the revised application process has been placed on the California website. The deadline for nominations was November 1, 2019. No nominations were received by State Excellence in Education Chairman Andrea Street by this deadline. The California winner receives \$200.00 from California Alpha Delta Kappa.

13.2. Communications Log

The Board reviewed the use of the Communications Log. It was decided to continue to use the Communications Log. Karen reminded the Board to use the Communications Log whenever the board members send or receive mail.

13.3. Regional Conference plans

Karen led a discussion of the board's travel plans for the Regional Conference to be held next summer in Hawaii. Discussion will continue in January, 2020.

13.4. State Convention Updates

13.4.1. Registration/online and due date

Karen is working on the registration packet. Karen will work with Diana on this packet. Karen wants to send a separate email to invite every California sister. Karen wants the registration form as well as the packet to be online for the State Convention to be held April 24-26, 2020. We are required to book at least 60 rooms at the Double-Tree Inn in San Jose, California. Karen encouraged the board to make reservations as soon as possible.

13.4.2. Sales at Convention

Chapters will be allowed to hold sales at the State Convention. Marlene has made a flyer to apply for sales space at the State Convention. The cost will be \$20 per table and will be awarded on

a first-come, first-served basis. Karen asked Marlene to send the flyer out after sisters receive the registration packet in January.

13.4.3. Board Members' Duties Review

Karen wants each board member to review their convention responsibilities and be prepared to discuss them at the January 24-26 Marina District Conference and Board Meeting.

13.4.4. Noel Leonard Grant Recipients

Each of the eleven councils should select one Noel Leonard First Timer Grant recipient from a list of first timers attending the State Convention. Chapters should submit First Timers' names to the Council. The Council President will conduct a drawing to select a recipient. Each recipient will receive \$100.00. The Noel Leonard Grant recipients' names will be due to Karen by April 1, 2020.

13.4.5. Eleanor Bendell State Scholarship

The Eleanor Bendell State Scholarship Award guidelines were read straight out of the Policies & Procedures. The award shall be given to a member of California Alpha Delta Kappa who is actively engaged in the field of education and is seeking professional growth. This year's allocation is \$2,500. The application is due to State Scholarship Chairman Rita Prichard February 25, 2020. If there is no qualified applicant in any given biennium, no award shall be given at that time.

13.4.6. Betty Rosenberg Golden Chapter Award

The Betty Rosenberg Golden Chapter Award will be given at the State Convention. Applications are due to Karen by February 15, 2020.

13.4.7. Convention Budget

Karen went over the California State Convention budget line by line. Karen is hoping that there will be at least 130 sisters attending the convention. The registration fee will be \$155. All information regarding the California State Convention to be held will be found in the registration packet coming out in January, 2020.

13.4.8. California Rules Governing the Convention

Karen read through the document called <u>Rules Governing the Convention.</u> The Board reviewed it.

13.5. Applications for Executive Board for 2020-2022

Karen stated that the application form to be considered for the next biennium's California Executive Board is now online on the California Alpha Delta Kappa website. To run for a position on the 2020-2022 Board, download the form, fill it in, and send it to Candidate Qualifications Chairman Barbara Ackleberry by November 30, 2019.

13.6. Summary of the Northern District Conference Evaluations

Karen thanked Sara for organizing the information gained from the Northern District's Conference evaluations. Sara sent each Board member the summary of the evaluations.

14. New Business

14.1. Policy & Procedures Updates

Diana keeps the Board's Policy & Procedures up to date. California is very forward thinking about the state's Policy & Procedures document. The Board discussed the need to change the deadline for the application to run for State Officer in the Policy & Procedures manual.

MOTION: Sara moved that the deadline for the application for state officers be moved to November 30, 2019. Rosena seconded the motion. The motion passed.

14.2. International Virtual Attendance

International Headquarters has sent California Alpha Delta Kappa Resolution #2 regarding Virtual Attendance to all state presidents for input. Karen is to report what the advantages and disadvantages might be.

14.3. School District Email Addresses

There was a reminder from Karen that working sisters should not use a school district email address as their Alpha Delta Kappa email address because newsletters, notifications, and emails may be blocked by the school district and not be delivered. It is recommended that school emails be changed to personal emails in the Directory on the International website.

14.4. International Bylaws

The discussion on the International Bylaws is postponed until next meeting.

14.5. Review H-103 Initiation Membership Application

Mari reported that there is only one form now that is easier to use. This information is on the international website. After a chapter has initiated a new member, the H-103 Membership Application Form should be completed and sent in. Form H-133 has been retired.

14.6. ITE Student/Rohina Sediqui

Karen asked Anita to send a sympathy card to an ITE Student named Rohina Sediqui. Her father died recently in Afghanistan. Anita sent the sympathy card to Rohina who is studying in Massachusetts. Anita included an invitation for Rohina to visit California if time allows one day.

14.7. Longest Day Chairman

Diana has been the California Chairman for the California Alpha Delta Kappa Longest Day Fundraising Campaign. Diana agreed to continue in this position for the 2020-2022 biennium.

14.8. Evaluation of the Valley District Conference

Rosena gave us her first impression of the evaluations that were turned in today after the Valley District Conference. There were 38 attendees. Eight of these attendees were the Executive Board. There were 25 evaluations returned. 19 of the evaluations gave a score of 5 which is the highest score. There were four with a score of 4. There were three without a score. There were not any evaluations with a score of 2 or 1.

14.9. Marina District Conference

Sara reported that the Marina District Conference will be held January 25, 2020 at Seal Beach, CA. Mari told us that the Conference will be held at the Seal Beach Old Ranch Country Club. Mari reported that the speaker will be Craig McDonald, a local historian.

15. Sales at the Valley District Conference

Marlene reported that 12 badge holders, one shirt, and two lanyards were sold today for a total of \$88.00.

Sara explained the specifics of sales at the Regional Conference sales in Hawaii. A chapter may sell crafts or packaged food. Hawaii sisters want to know how many tables to set up. The Board will discuss this in January, 2020.

Virginia presented us many interesting facts about Veterans Day. This holiday honors all who have served the country, both in war and peace, dead or alive, although it is largely intended to thank living veterans for their sacrifice.
